

# TERMS OF SERVICE

## SOCIALREMIT BLOCKCHAIN NETWORKS LTD

### 1. User registration

- Only one user registration per person or company will be admitted. The registration of the same person or company with different email or Ethereum accounts is expressly prohibited.
- After the user registration you will receive an email to validate your email account and Ethereum. The validation of this mail does not mean the complete registration of the user.
- After the validation of the mail account and Ethereum, the tokens that will be granted based on their activity will be assigned to the registered user account. The tokens will be assigned provisionally pending the completion of the ICO when manual verification of validated referrals and campaign activity in social networks will be carried out. 60 days after the end of the ICO, the final tokens will be assigned.
- By accepting the conditions of use of its registration, the user is accepting all the conditions established in this document and some of them that develop the content of the WHITEPAPER.

SOCIALREMIT BLOCKCHAIN NETWORKS LTD reserves the right to cancel the registration of users who have registered with more than one Ethereum account and / or mail, or do not attend in a timely manner to present proof of identity, address or source of money before the completion of the ICO.

### 2. AIRDROP. Assigned tokens for users (except special campaigns)

They will be distributed according to the following criteria:

- Minimum of validated referrals to be able to exchange CSR to EaD tokens: 5.
- Maximum allowed referrals: Unlimited
- Tokens assigned by referrals that have validated mail: 20 tokens
- Reward maximum totals per campaign on social networks (Facebook, Twitter, Telegram, LinkedIn, Reddit, BitcoinTalk, Medium, Written articles) total 350 tokens.

SocialRemit will be able to unilaterally correct the total of rewarded tokens if you observe indications of fraud or having violated the conditions of service by the registered user.

The definitive tokens assigned will be transferred to registered users in the 60 days after the end date of the ICO once the data has been validated of identification, address and / or income of said users and referrals.

### 3. AIRDROP. Redeem tokens CSR by tokens EaD

To be able to exchange your CSR tokens obtained by referrals and activity on social networks by tokens, EaD the registered user must prove

- The user must have validated their identity, address and if applicable proof of income
- The user must prove that they have a minimum of SRT tokens equivalent to 125 USD
- The user must certify a minimum of 5 validated referrals that have SRT tokens equivalent to 50 USD.

All those registered who will be considered validated referrals have registered through the link assigned to the user, and who have also accredited your mail, identity, address and have equivalent SRT tokens equivalent to 50 USD

- **For registered users**
  - Proof of identity (One of the following documents: passport, driver's license, identity document of the country)
  - Proof of address (one of the following documents: receipt of water, electricity, gas, landline telephone, rent, bank statement, mortgage, medical insurance, etc.)
- **For referrals by registered users**
  - Proof of identity (One of the following documents: passport, driver's license, identity document of the country)
  - Proof of address (one of the following documents: receipt of water, electricity, gas, landline telephone, rent, bank statement, mortgage, medical insurance, etc.)
  - In the case of investments over USD 12,000, SOCIALREMIT BLOCKCHAIN NETWORKS LTD reserves the right to request evidence of source of funds and / or declarations tributary

- When the referred one requests the reimbursement of the tokens of his account he must do it to the current account or card of origin of the same in order to avoid money laundering. In the cases that these current accounts or bank cards have been canceled you must prove the withdrawal in the bank and a new account of the same owner to transfer the funds.
